## LAXTON PARISH COUNCIL

27 October 2015

**PRESENT:** Councillors Yarrow (in the Chair), Bray, Collins and Moore.

Clerk: Alan Bravey

Ward Councillors: Councillors Aitken and Bayram.

There was one member of the public present.

Apologies for absence were submitted by Councillor Sweeting.

The Parish Council met at Victory Hall, Laxton.

162/15 **COMMUNITY LED PLANNING** – Peter Hirschfield from the Humber and Wolds Rural Community Council (HWRCC) gave a presentation on the benefits of holding a community review consultation event and developing a community led plan. The process could strengthen the relationship between the Parish Council and the community as well as providing a road map for future Parish Council activities. HWRCC offered to conduct the consultation on behalf of the Council at a cost, which could probably be met through a National Lottery Grant.

**Resolved** – (a) that the Clerk would request a copy of the Burtswick Parish Council plan as an example and explore the benefit of grant funding and (b) that the issue would be discussed further at a future meeting.

163/15 **MINUTES – Resolved** - That the minutes of the meeting of the Council held on 22<sup>nd</sup> September 2015 should be confirmed as a correct record and signed by the Chair.

164/15 **DECLARATIONS OF PECUNIARY AND NON-PECUNIARY INTERESTS** – Councillor Collins declared a pecuniary interest in the planning consultation 15/03017/VAR and took no part in the discussions on that item.

165/15 **COUNCILLOR CO-OPTION - Resolved** - To defer this agenda item until the next meeting.

166/15 **CLERK UPDATE**– It was reported that half the potential appointments on the Public Health bus had been booked, which was seen as a successful visit by the operators. Cllr Moore reported that a series of revised plans had been submitted for the Old Blacksmith's Cottage. The Clerk advised that he would include an application for a Parish Council laptop in the transparency fund bid.

167/15 **WARD COUNCILLOR UPDATE**– Cllr Aitken provided an update on the budget cuts faced by East Riding of Yorkshire Council, information on a petition on levels

of school funding received in the East Riding of Yorkshire and a progress report on flood defences. Drainage issues at Cotness Corner and with the Clough Doors were discussed and it was noted that target start date for the new pump house was January 2016.

168/15 **PUBLIC PARTICIPATION** – There was no public participation.

(b) that future consideration be given to linking into the youth projects being undertaken in Gilbertkye and Newport, (c) the Parish Council would sign the Fair School Funding Petition, (d) the Clerk would respond to the ERNLLCA consultation, (e) the Clerk would attend the Good Councillor training, (f) the Clerk would arrange for a satellite broadband provider to outline their services at a public meeting, and (g) enquiries would be made to Humberside Police on their views in in applying to the Police Commissioners to fund some limited CCTV for the village.

170/15 **PLANNING MATTERS – Resolved** – to advise East Riding of Yorkshire Council that the Parish Council had no objections to the revised drawings for 15/03017/VAR Old Vicarage, Chapel Lane, Laxton, but to record that the Parish Council could not support any future conversion to a dwelling as the development was outside the village limits.

171/15 **PUBLIC TRANSPORT REVIEW** - Councillor Yarrow reported that East Riding of Yorkshire Council were carrying out a review of how public transport was provided in the area and had asked Parish Councils to help identify local transport needs.

**Resolved** – (a) that the Clerk should seek the views of Kilpin and Blacktoft Parish Councils in nominated a single champion for the 160/162 bus route (b) that Councillors speak try to speak with people who use the current service.

172/15 **HIGHWAYS AND DRAINAGE ISSUES** – East Riding of Yorkshire Council were in the process of repairing a gully damaged by tree routes on St Peters Lane, but had yet to complete the works. Concern was raised at the condition, smell and potential flood risk of a drain near to Church Close, which was under riparian ownership.

**Resolved** – (a) to write to East Riding of Yorkshire Council about the work on St Peters Lane and (b) to write to the owner of the drain near Church Close and send a copy to the Drainage Board.

173/15 **COMMUNITY DEFIBRILLATOR** – A community defibrillator cabinet had been fitted in Laxton and was expected to be fitted in Saltmarshe in the next few days. Once installed, the Clerk would arrange training and the introduction of the Village Emergency Telephone System.

174/15 **SIXPENNY WOOD GRANT APPLICATION** – The meeting discussed a draft grant application to the community benefit fund for a contribution towards the 5 year purchase, administration, maintenance and training costs for the community defibrillators. Councillor Bayram agreed to provide a reference.

**Resolved** – (a) that the application should be submitted.

175/15 **COMMUNITY EMERGENCY PLAN** – It was noted that Parish Councillors had recently checked on the equipment in the two emergency stores.

176/15 **CLAY PIGEON SHOOTING** – The meeting discussed a recent clay pigeon shoot. **Resolved** – That the situation should be monitored.

177/15 **MONTH 6 BUDGET MONITORING AND ACCOUNTS FOR PAYMENT** - The Clerk presented the six monthly budget monitoring statement. Councillor Aitken congratulated the Council on its proactive work over recent months.

**Resolved** – That the budget monitoring be received and the following accounts approved for payment:
